Bachelors in Peace Studies-The program divides its curriculum of primary and cross listed courses into three areas. The first is the role of international norms, institutions, and states in a peaceful world order. The courses explore ways to make governmental and intergovernmental institutions more effective and to strengthen government compliance with norms of peace and human rights. The second is the impact of religious, philosophical, and cultural influences on peace. These courses focus on ethics of the use of force; theological and philosophical visions of global justice; how the world's religious traditions foment violence or encourage peace; the practice of non violence; and the linguistic, literary, and historical dimensions of cultures of peace. The third section is the promotion of social, economic, and environmental justice. These courses examine social change, with specific attention to the role of nongovernmental organizations, commercial enterprises, and states in fostering sustainable economic development, respect for human rights, conflict resolution and non-violent conflict transformation, support of gender and family issues, and protection of the environment.

Peace, conflict, and coexistence bachelors minor: Since the end of World War II, Peace, Conflict, and Coexistence Studies (PAX) has emerged as an interdisciplinary area of inquiry drawing on social science, the humanities, the creative arts, and science in efforts to understand reasons for war and possible ways of resolving conflicts without resorting to violence. In the last few years, for many people the primary focus of inquiry is shifting from the Cold War and the nuclear threat to conflict resolution in small and large contexts. Along with the larger goal of ending war altogether, the Brandeis program reflects this tendency. This is a time to examine the many meanings of "security;" to investigate the nature of power and political participation and to develop ideas and ways of addressing conflicts that honour the integrity of all parties involved. This is a time, in other words, to learn alternatives to violence and a time to learn the ways of disarmament and of ending war.

Master of Arts in Coexistence and Conflict

The master's program in coexistence and conflict has been designed to suit the requirements of people and organizations working in divided and conflicted societies, at local, national, and international levels, who want to learn how to more effectively prevent, manage, and resolve such conflicts. Participants reflect upon the different kinds of ethnic, religious, and cultural conflicts that have been emerging around the world, particularly since the end of the Cold War, and the reasons for such an emergence. They will also look at the theories of contemporary inter communal conflict as well as strategic interventions to such conflicts, including political, meditative, cultural, legislative, and developmental approaches. The program also offers students the opportunity to develop dialogue and mediation skills for use in situations of intercommunal conflict.

MA in International Peace and Conflict Resolution: The 39-credit program explores the following critical issues: theories on the causes of war and organized violence at the international and intra-national levels, alternative approaches to resolving and preventing conflict, approaches to peacemaking, the formation of cooperative global relationships, cross-cultural negotiation, crisis management and response, and individual and community transformation. Students learn to analyze current conflict situations and develop policy proposals for their resolution.

MA in Ethics, Peace, and Global Affairs: The program prepares students broadly in the practical application of ethical theory and policy analysis to difficult ethical choices in global affairs, and specifically to the dynamics of war, peace, and conflict resolution. Hallmarks of the curriculum include interdisciplinary inquiry; solid grounding in the foundational concepts and issues of both philosophical ethics and international affairs, practical applications of ethical and policy analysis to contemporary social problems in global affairs; and interactive teaching utilizing case studies, simulations, interactive exercises, and intensive class discussion. Students select one of six different tracks—specially selected sets of courses in a content area of specialization. These tracks are human rights and social justice, peace and

conflict resolution, global environmental justice, ethics of development, international economic justice, and global governance and international organizations.

PhD-Graduate Certificate in Conflict Transformation – designed for professional and lay people who wish to develop expertise in a particular area of the Conflict Transformation field. The certificate complements a previously obtained graduate degree or years of practical experience in another field. Details on degree requirements and core requirements are noted above.
